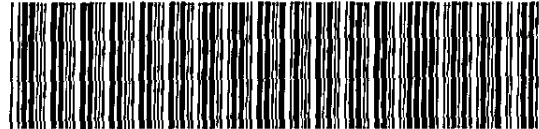

ARTICLE I: NAME

The name of this corporation, which shall be a corporation not for profit incorporated pursuant to Chapter 617, Florida Statutes, is Hope for Tomorrow Outreach Ministries, **INC.**

ARTICLE II: DURATION

The term for which the corporation shall exist shall be perpetual.

ARTICLE III: PURPOSE

The purpose of the corporation shall be to develop and implement programs for youth-at-risk, the elderly and the needy within the neighborhood served by the program. The programs shall include, but not be limited to, providing food and clothing to the indigent needy, mentoring and literacy programs for neighborhood youths and their families, teen pregnancy programs and providing material and counseling and spiritual support for the neighborhood elderly and needy.

ARTICLE IV: ADDRESS

The street address of the initial principal office shall be 6728 N.W. 18 Avenue, Miami, Florida 33147. The mailing address of the corporation shall be the same.

ARTICLE V: SELECTION OF DIRECTORS

The method of election of Directors shall be stated in the bylaws.

ARTICLE VI: NONSTOCK BASIS

The Corporation is organized on a nonstock basis.

ARTICLE VII: REGISTERED OFFICE AND REGISTERED AGENT




