Pursuant to the provisions of Chapter 617, Florida Statutes, the undersigned incorporators hereby adopt the following Articles of Incorporation:

#### Article 1

The name of this corporation is as follows: The Tattooed Ballerinas, Inc.

#### Article 2

The principal place of business of this corporation is as follows:

#### **Article 3**

The purpose for which this corporation is organized is dance performance, education, presentation, and related activities for the general public.

This corporation is organized exclusively for one or more of the purposes as specified in section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organization under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### Article 4

This corporation shall have one class of directors who shall serve on a board of directors. Each director shall hold office for a period of time as determined by the corporation's bylaws and until his or her successor is elected and qualifies. Officers shall be elected by the board of directors, at any time, and each officer shall hold office until he or she resigns or is removed or is otherwise disqualified to serve, or until his or her successor shall be elected and qualified, whichever occurs first. Admission of new directors to the board shall require majority quorum rule by existing directors. Vacancies on the board of directors shall exist (1) on the death, resignation, or removal of any director, and (2) whenever the number of authorized directors is increased.
