The undersigned, acting as incorporator(s) of a corporation, in compliance with Chapter 617, F.S., A Corporation Not for Profit, adopt(s) the following Articles of Incorporation:

ARTICLE I: NAME

The name of this organization shall be the River Ridge Middle School Band Boosters, Inc. (RRMSBB).

ARTICLE II: PRINCIPAL OFFICE

The principal office of this organization shall be located in the state of Florida with the principal place of business and a mailing address of C/O Middle School Band Director, 11646 Town Center Road, New Port Richey, FL 34654.

ARTICLE III: PURPOSE

The purpose of this association is to support the band director in the direction he or she is pursuing; to enthusiastically support the students in the music program so as to provide a richer school experience for those students; and to build and maintain an organization which will help promote the general activities of the River Ridge Middle School Band Program. And to operate exclusively in any other manner for such educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code, as amended, or under any corresponding provisions of any subsequent federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended. To this end, the association will support the middle school band program through active participation:

- (a) To assist the band program in fund raising activities;
- (b) To serve as chaperons on any Board Approved Functions;
- (c) To maintain and disperse funds;
- (d) To establish and maintain a positive moral and pride in the band program;
- (e) To receive, acquire, hold gifts, donations, and bequests;
- (f) To cooperate with other organizations which have objectives similar in whole or in part to the objectives of this organization; and
- (g) To maintain the highest standards of creativity, performance, and most importantly, education.

ARTICLE IV: MANNER OF ELECTIONS

The manner in which the directors are elected or appointed are determined by the By-laws as adopted by the membership of the organization
