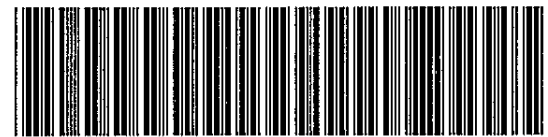

**ARTICLES OF INCORPORATION
OF
PARENTS' ATTORNEYS ASSOCIATION OF FLORIDA, INC.
(a not for profit corporation)**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporations Not For Profit Act, hereby files these Articles of Incorporation:

ARTICLE I -- NAME

The name of the corporation shall be

PARENTS' ATTORNEYS ASSOCIATION OF FLORIDA, INC.

ARTICLE II -- ADDRESS

The mailing address of business of the corporation shall be:
P.O. Box 10426, Tallahassee, FL 32302.

The principal place of business of the corporation shall be:
203 N. Franklin Blvd, Tallahassee, FL 32301.

ARTICLE III -- PURPOSES

This corporation is formed for the purpose of providing assistance, coordination and support to families who are at risk because of state action.

This corporation may have any purpose lawfully allowed as a not for profit corporation under Chapter 617, Florida Statutes.

This organization is organized strictly for charitable, educational and scientific purposes excluding for such purposes the making of distributions to organizations that qualify as exempt organization under the Internal Revenue Code.

ARTICLE IV -- POWERS

This corporation may exercise any and all powers as are in furtherance of the purposes of its organization and as are enumerated in section 617.0302, Florida Statutes(2005), providing such powers are permitted so as to provide a tax exempt status as determined by the U.S. Department of Treasury, Internal Revenue Service.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under the Internal Revenue Code.

No part of the net earnings of the organization shall inure to the benefit of or be distributed to its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be to intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE V -- MEMBERS

A. The members of this corporation shall have no right nor interest in the property of the corporation except voting.

B. The qualifications of the members, the manner of their

admission and termination of membership, and voting by members shall be as stated in the By-Laws.

C. Membership in this corporation is fully transferable.

ARTICLE VI -- REGISTERED AGENT

The name and address of the initial registered agent of the corporation is Joyce Sibson Dove, Attorney at Law, 203 North Franklin Blvd, Tallahassee, Florida 32301.

ARTICLE VII -- INCORPORATOR

The name and address of the incorporator of these Articles of Incorporation is:

ARTICLE VIII -- DIRECTORS

The number of directors constituting the board of directors of the corporation are three, and the names and addresses of the persons who are to serve as directors until the first annual meeting of members or until their successors are elected and shall qualify are:

ARTICLE IX -- AMENDMENTS


Amendments to these Articles shall be adopted by a vote of two thirds of the directors present at a meeting called for that purpose as provided for in the By-Laws.

ARTICLE X -- DISSOLUTION

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government or a state or local government for a public purpose. Any such assets not so disposed of shall be disposed by the court of Florida, so organized for such purpose, exclusively for such purposes or to such organizations as said Court shall determine which are organized and operated exclusively for such purposes.


