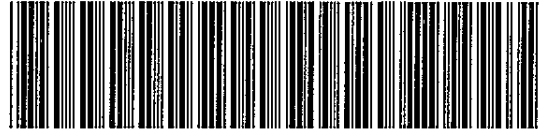

ARTICLES OF INCORPORATION  
OF

A Florida Not for Profit Corporation

**Article I – Name**

The name of this "Not for Profit" corporation shall be: "***The Arc Development Center, Inc.***".

**Article II – Principal Place of Business**

**Article III – Effective Date**

The commencement of this corporation will take effect upon the filing of this document.

**Article IV – Purpose**

The purpose of this corporation is to establish and provide a community based center that services the educational needs of the community's youth, provides assistance to the elderly, and offers assistance to financially challenged individuals seeking to become entrepreneurs. The Corporation is organized, and will be operated, exclusively for charitable, educational, and scientific purposes within the meaning of § 501 (c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), or the corresponding provision of any future United States tax code. Any reference in these Articles to the Code shall include the corresponding provisions of any further United States tax code.

- a. The Corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from United States income tax under § 501 (c)(3) of the Code or (ii) by a corporation, contributions to which are deductible under § 170 (c)(2) of the Code.
- b. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall be empowered to make the election under § 501 (h) of the Code.
- c. The Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
- d. No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes as set forth in Article IV.

#### **Article V – Dissolution**

In the event of the dissolution of "The Arc Development Center, Inc.", the Corporation's assets shall be distributed for one or more of the exempt purposes set forth in Article IV hereof to a § 501 (c)(3) organization organized and operated exclusively for such purposes as outlined in the Internal Revenue's Code § 501 (c)(3).

#### **Article VI – Manner of Election of Officers/Directors**

The corporation may (but need not) have voting members, and such membership, if any, and classes thereof, shall be as defined in the corporation's bylaws. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws.

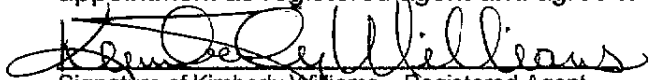
