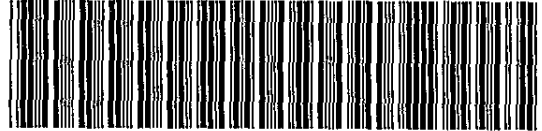

Article Four: The purpose of the Corporation is to provide college scholarships to high school graduates in Collier County, Florida. No part of the earnings shall inure to any member.




