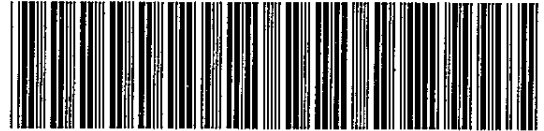

The undersigned incorporation hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I.

The name and address of this principle corporation is: THE COMMONWEALTH FAMILY OUTREACH MINISTRY, INC. 2124 N.E. 25TH ST Cape Coral, Florida 33909 in Lee County. The corporation is organized pursuant to Florida non-profit corporation code.

ARTICLE II.

This corporation is a non-profit public benefit corporation and is not organized for private gain of any person. The corporation is organized under the non-profit public benefit corporation law, for charitable and educational purposes. To minister and aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. To design, implement and sustain Ministries, Programs and classes that focus on the total development of mankind. To teach the three keys and seven books, to restore the faith, love, and joy in the heart of mankind, to teach character building, moral values, pride in home and community, self-development, educational, and career development to those individuals who need further training in social and personal competencies that will help them to master their life skills development to deal more effectively with everyday situations and life events, and other programs to aid those in need.

ARTICLE VII.



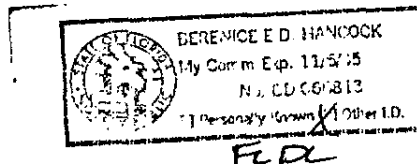
