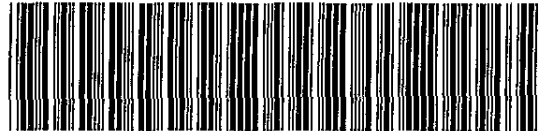

Of
