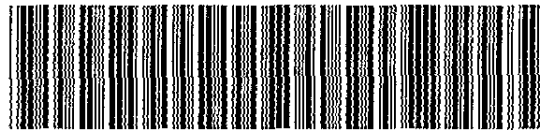


Subject: Resignation from Natura Fellowship, Inc. Florida Naturist Park, Continuing Care Inc. and any other unknown related entities.
