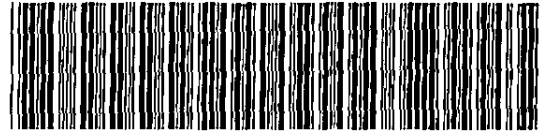

Articles of Incorporation
For

Divine Pathways Metaphysical Church, Inc.

THE UNDERSIGNED, acting as incorporators of a corporation under Florida General Corporation Act, adopted the following articles for such incorporation:

Article I

The principle place of business is: 12417 Clocktower Pkwy,
Hudson, FL 34668

Article II

The period of its duration is perpetual, unless dissolved according to law.

Article III

The general purposes for which this corporation is organized are exclusively religious, charitable, literary or educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code. Without limiting the generality of the foregoing Divine Pathways Metaphysical Church, Inc. Is organized to act as a church for the sole purpose of proclaiming, promulgation of philosophy, promotion of science, the study of phenomena and the religion of Divine Metaphysics in an effective manner.

This corporation shall have the power to purchase, lease or otherwise acquire property, support missionaries and missions, raise funds, and do those things necessary to proclaim the religion of Divine Metaphysics in an adequate manner.

Notwithstanding any other provision of these articles, this organization shall not carry on any activity not permitted to be carried on by an organization exempt from Federal Income Taxes under Section 501(c)(3) of the Internal Revenue law.

Article IV

The qualification for members and the manner of their admission are set forth in the Bylaws of the Corporation. The manner in which the Board of Trustees shall be appointed or elected will be determined by the Bylaws.

Article V


Article VIII
