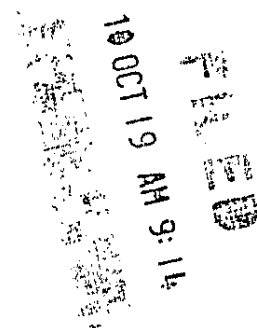

ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION OF CROSS OF LIFE CHURCH, INC.
