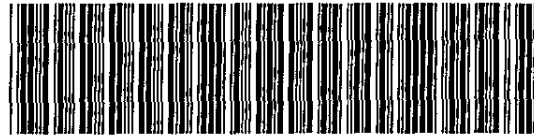

ARTICLE I NAME

THE NAME OF THE CORPORATION SHALL BE: UNITED CHILDREN'S PROTECTOR OF AMERICA, INC. A NOT-FOR-PROFIT CORPORATION.

ARTICLE II PRINCIPAL OFFICE

THE PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS OF THIS CORPORATION SHALL BE; 9124 S.W. 150 AVE., MIAMI, FL. 33196.

ARTICLE III PURPOSE

- 1. TO SUPPORT TO THE INTEGRAL DEVELOPMENT OF THE CHILDREN IN SITUATION OF IT CARRIES TO AN EXTREME POVERTY DE LATIN AMERICA, PROMOTING AND DEFENDING THEIR RIGHTS (ACCESS TO THE EDUCATION AND THE CULTURE, TO THE PHYSICAL AND MENTAL HEALTH AND THE NUTRITION).**

- 4. TO PROMOTE PROGRAMS OF LABOR TRAINING, LABOR AND PRODUCTIVE ACTIVITIES, DIRECTED TO MOTHERS, WOMEN AND YOUNG OF BOTH SEXES IN SITUATION OF POVERTY AND EXTREME POVERTY DE LATIN AMERICA.**
