Articles for Incorporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts(s) the following Articles of Incorporation:

ARTICLE I NAME

The Name of the corporation shall be: New Nations Christian Ministry, Inc.

ARTICLE II PRINCIPLE OFFICE

The principle mailing address of this corporation shall be: The mailing address is 14334 Clarkson Dr. Orlando, Florida 32828.

ARTICLE III PURPOSES

The specific purpose(s) for which the corporation is organized is (are):

The principle purpose of the Corporation is to operate a non-profit church which will proclaim the Gospel of Jesus Christ in and around Orlando, Florida, and to the very ends of the Earth and to encourage Christians in the living of their faith in accordance with GOD's Word by example, teaching and exhortation.

(A) The specific and primary purposes are:

- (1) The corporation is irrevocably dedicated to and operated exclusively for nonprofit purposes.

(B) In furtherance, the purposes and powers are to have and exercise all rights and powers conferred on nonprofit corporations under the laws of Florida, or which may hereafter be conferred, including the power to contract, rent, buy or sell personal or real property; provided, however, that this corporation shall not except to an insubstantial degree, engage in any activities or exercises any powers that are not in furtherance of the principle and primary purpose of this corporation.

(C) In furtherance, but not limitation of the foregoing, the corporation shall have the following powers:

- (1) To be a church, abiding by New Nations Christian Ministry constitution.
- (2) To promote the spiritual welfare of people and in particular the members of this church.
- (3) To operate an educational institution of wherein the students may obtain a sound general education of the highest order within the beliefs and values of the church.
- (4) To generally do all acts necessary or expedient in connection with these purposes as permitted by the laws of the State of Florida.

ARTICLE IX TO THE ARTICLES


These articles may be amended or repealed, in whole or in part, by a majority vote of the Board of Directors.
