The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida Not for Profit Corporation Act, by and under the provisions of the Statutes of the State of Florida, hereby adopts the following Articles of Incorporation.

ARTICLE I- NAME

The name of the corporation shall be COASTAL COMMUNITY CHURCH, INC.

ARTICLE II- OFFICE

The principal office of this corporation shall be situated at 1832 S CENTRAL AVENUE FLAGLER BEACH, FLORIDA 32136 and said corporation shall have the rights and privileges of business in such states of the United States and foreign countries whenever the Board of Directors may from time to time order and establish.

ARTICLE III- REGISTERED AGENT

The street address of this corporation's initial registered office will be 1832 S CENTRAL AVENUE FLAGLER BEACH, FLORIDA 32136 and the name of its initial registered agent will be RODERICK J PALMER at such address.

ARTICLE IV- NATURE OF BUSINESS

The purposes and powers of this corporation are to engage in and have unlimited power to do any and all lawful purposes, by all lawful powers, of a corporation not for profit pursuant to the laws of the United States and the laws of the State of Florida. The specific purpose of this institution is to be active in the great commission as commanded in the Holy Bible by preaching and teaching the gospel of Jesus Christ and by the use of printed material or any other lawful method whenever and where ever the opportunity may otherwise arrive.
