

**ARTICLES OF INCORPORATION**  
**OF**  
***SOUTH BAY BUILDING CONTRACTORS TECHNICAL INSTITUTE, INC.***

**ARTICLE I.**

The name of the Corporation shall be "*South Bay Building Contractors Technical Institute, Inc.*"

**ARTICLE II.**

The Corporation is organized pursuant to the Florida Nonprofit Corporate Code.

**ARTICLE III.**

The Corporation shall have perpetual duration.

**ARTICLE IV.**

The Corporation will be organized exclusively for charitable and educational purposes within the meaning of Section (c) (3) of the 1986 International Revenue code.

**ARTICLE IV(a).**

The purpose of the corporation is to teach and educate men and women how to read blue prints, lay foundations, lay concrete, tile installation, plumbing installation, electrical installation, roofing, stucco work, painting, carpentry and more.

**ARTICLE V.**

The method of election of the Corporation's directions shall be set forth in the Bylaws of the Corporation.

**ARTICLE VI.**

Notwithstanding any other provision of these articles the corporation will not carry on any other activities not permitted to be carried out by:

- a) A corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law; or
- b) A corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any

#### ARTICLE VIII.




