# ARTICLES OF INCORPORATION OF

05 MAR 18 PM 2: 12

KINGDOM HARVEST MINISTRIES, INC. SECRETARY C. STATE

#### ARTICLE I.

The name of the Corporation is "Kingdom Harvest Ministries, Inc."

### ARTICLE II.

The Corporation is organized pursuant to the Florida Non-Profit Corporation Code.

#### ARTICLE III.

The Corporation shall have perpetual duration.

# ARTICLE IV.

The Corporation will be organized exclusively for religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the 1986 International Revenue Code.

## ARTICLE IV(a).

The purpose of this corporation is: 1) to acknowledge the manifestation of the Church in which Jesus Christ ministered to all nations; 2) to fulfilling this calling through religious practice in pastorship, teaching, evangelism, revivals, salvation, baptism, counseling, marriage, outreach, charity, education and corporate worship service 3) to proclaiming the gospel by work and deed as servants to meet individual; 4) to transform and empower lives through education, charity and scientific support groups for marital counseling for pre-marriages and existing marriages; adult and youth outreach; counseling and assisting alcoholics, drug addicts, prevention and intervention program for youth, teens and adults; and care groups to assist individuals socially and economically; 5) to transform and empower lives through demonstration of the love and the power of God reaching all of mankind by fostering relationship through public, private and government entities in accordance to our faith and belief, all in the name of Jesus Christ.

#### ARTICLE V.

The method of election of the Corporation's directors shall be set forth in the Bylaws of the Corporation.

#### ARTICLE VI.

Notwithstanding any other provision of these articles the corporation will not carry on any other activities not permitted to be carried out by:

- (a) a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law; or
- (b) a corporation contributions to which are deductible under Section 178(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States Revenue Law.

#### ARTICLE VIL

Upon dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, ie., charitable, education, religious or corresponding section of any future tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.

#### ARTICLE VIII.

The initial registered office of the Corporation shall be 1616 Crooked Stick Way, West Palm Beach, Florida 33413 and the initial registered agent of the Corporation at such address shall be Pastor J. R. Thicklin.

#### ARTICLE IX.

The initial mailing address of the principal office of the corporation shall be P.O. Box 10916, Riviera Beach, Florida 33404.

#### ARTICLE X.
