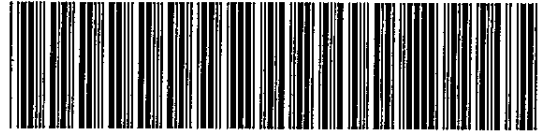

**ARTICLES OF INCORPORATION  
OF THE  
GREATER FRENCHTOWN AREA FRONT PORCH FLORIDA  
REVITALIZATION COUNCIL, Inc.**

**ARTICLE 1. NAME:** The name of the not-for-profit shall be Greater Frenchtown Area Front Porch Florida Revitalization Council, Inc.

**ARTICLE II. PRINCIPAL OFFICE:** The principal place of business and mailing address of this organization shall be 438 W. Brevard Street, Tallahassee, Florida 32301.

**ARTICLE III. PURPOSE(S):** The purpose/mission for which the organization is organized is to provide information and assistance to community residents in revitalization and development.

- A. The purposes for which be Greater Frenchtown Area Front Porch Florida Revitalization Council are organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United State Internal Revenue Law.
- B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United State Internal Revenue Law.
- C. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501 (c) (3) and 107 (c) (2) of the Internal Revenue Code of 1986 or the corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or Local government for exclusive public purposes.

**ARTICLE IV. MANNER OF ELECTION OF DIRECTORS:** The manner in which the Directors are elected or appointed is stated in the bylaws.

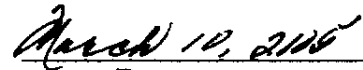

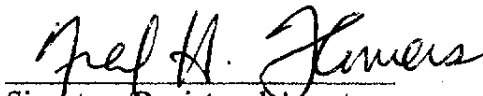

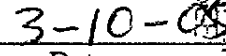
