

**Article III**

The purpose for which this corporation is organized is:

THIS ORGANIZATION SHALL BE COMPRISED OF ALL VOLUNTEER SCUBA DIVERS AND SUPPORT STAFF, PROVIDING ALL OF THEIR OWN EQUIPMENT AND LOGISTICAL SUPPORT, STRICTLY FOR CHARITABLE PURPOSES, INCLUDING COMMUNITY SERVICE AND VICTIM FAMILY SUPPORT, NOT FOR COMPENSATION OR REIMBURSEMENT OF ANY LABOR, MATERIALS, OR EXPENSES INCURRED IN THE EXECUTION OF SAID RECOVERY EFFORTS; INVOLVING EMERGENCY RESCUE/BODY RECOVERY FROM THE EX- U.S.S. ORISKANY (THE ARTIFICIAL REEF) AND ITS SURROUNDING AREA. ANY CHARITABLE DONATIONS TO THE ORGANIZATION SHALL BE HELD SPECIFICALLY FOR USE AGAINST DIRECT EXPENSES OF MAINTAINING THE CORPORATION, SUCH AS MAINTAINANCE OF THE CURRENT STATUS OF A NON-PROFIT 501 (C)-(3) CORPORATION WITH THE IRS, AND THE MAKING OF DISTRIBUTIONS TO ORAGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. IF, DURING ANY FISCAL YEAR, THE ANNUAL OPERATING EXPENSES OF THE ORGANIZATION APPROACH WITHIN \$1000.00 OF THE ANNUAL LIMIT OF \$10,000.00, HEREBY BEING A \$9000.00 LIMIT, ALL OPERATINS OF THE ORGANIZATION SHALL CEASE, PREVENTING ANY FURTHER EXPENSES, UNTIL AFTER THE NEW FISCAL YEAR.

UNDER THE DISSOLUTION OF THE ORGANIZATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE, OR CORRESPONSING SECTION OF ANY FUTURE FEDERAL TAX CODE, INCLUDING TO THE LOCAL ESCAMBIA COUNTY, FLORIDA'S SHERIFFS'S DEPARTMENT MARINE RESPONSE UNIT. ANY ASSETS NOT DISPOSED OF SHALL BE DISPOSED OF BY THE COURT OF COMMON PLEAS OF ESCAMBIA COUNTY, EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH ORGANIZATION, AS SAID COURT SHALL DETERMINE, WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.
