**ARTICLES OF INCORPORATION
OF
CHILDREN IN THE NEIGHBORHOOD INC.**

ARTICLE I.

The name of the Corporation is *Children In The Neighborhood, Inc.*

ARTICLE II.

The Corporation is organized pursuant to the Florida Non-Profit Corporation Code.

ARTICLE III.

The Corporation shall have perpetual duration.

ARTICLE IV.

The Corporation will be organized exclusively for charitable and educational purpose within the meaning of Section 501(c)(3) of the 1986 International Revenue Code.

ARTICLE V.

The method of election of the Corporation's directors shall be set forth in the Bylaws of the Corporation.

ARTICLE VI.

Notwithstanding any other provision of these articles the corporation will not carry on any other activities not permitted to be carried out by:

- (a) a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law; or
- (b) a corporation contributions to which are deductible under Section 178(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States Revenue Law.

ARTICLE VII.

The initial registered office of the Corporation shall be **700 S.W. Martin Luther King, Jr. Blvd., Belle Glade, Florida 33430** and the initial registered agent of the Corporation at such address shall be **Lester Finney**.

ARTICLE IX.




