UNDER CHAPTER 617, FLORIDA STATUTES (F. S.) NON- PROFIT CORPORATION LAW

The undersigned incorporator, in order to form a non-profit corporation under the laws of the state of Florida, adopts the following Articles of Incorporation:

ARTICLE I - NAME:

The name of the corporation is **NEVER ENDING MINISTRIES**, **INC**.

<u>ARTICLE II – PRINCIPAL OFFICE:</u>

The principal place of business shall be located in Palm Bay, Brevard County, Florida.

ARTICLE III - PURPOSE:

This corporation is organized exclusively for religious purposes within the meaning of section 501 © 3 of the internal revenue code. Notwithstanding any other provision of these articles, the corporation is organized exclusively for one or more of the purposes as specified in Section 501 © 3 of the Internal Revenue code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 © 3, of the Internal Revenue Code, or corresponding section of any future federal tax code.

The purpose of NEVER ENDING MINISTRIES, INC. is to teach, preach, and evangelize the gospel of Jesus Christ. To establish a church location for participants; counseling (spiritual and provide community support through outreach to the needy.

In furtherance of this charitable purpose the Corporation shall, but is not limited to the following;

- a) Provide bible studies, to include, but not limited to: old and new testament teachings; bible studies in references to modern times; the life and teaching of Jesus Christ and the power in the Word of God. These teaching will be geared towards sharing and spreading the gospel of Jesus Christ. Other materials will be utilized upon approval by the board of directors.
- b) Conduct evangelism to the general public through outreach programs, to include but not limited to: street outreach; home visitations; hospital visitations; outdoor concerts and other events as required by the community and permitted by law.
- c) Implement and promote a prison ministry, to include but not limited to: visitations of inmates in jails and state prison facilities; in order to assist inmates with transition back into the community locate churches and employers that are willing to accept prisoners upon their release: act as a resource conduit; letter writing to inmates and their families. These activities will be conducted with the dual purpose of sharing the gospel of Jesus Christ and assisting inmates in becoming productive members of society.
- d) Develop a diversified network of support and training groups which focuses on empowerment strategies to help individuals and families overcome feelings of powerlessness.
- e) Conduct, plan, sponsor, promote and implement leadership training programs; mentoring programs; networking programs; musical and theatrical programs; job readiness programs; projects and activities in cooperation with governmental agencies and other community organizations and institutions designed to promote guidance, training and support to those individuals who attend Never Ending Ministries; their families, friends and the general public.

F) These activities will focus on empowerment strategies, in order to lessen the burden of government, by providing the participants with the tools that will make them more productive citizens.

In furtherance of the foregoing purpose, the Corporation shall have the right to conduct any and all lawful activities, both alone and Cooperation with other persons or organizations, which may be necessary or proper or incidental to or connect with the accomplishing or the advancing the foregoing purposes.

Any additional provisions for the operation of the corporation are as follows.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501 (h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

The manner in which the directors are elected or appointed shall be fixed by, or determined in accordance with the BY-LAWS, but in any case shall not be less than three (3).
