ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The purpose for which this organization is formed is exclusively for charitable, education, religious, artistic, literary and scientific purposes as described in the nonprofit public benefit law within the meaning of section 501(c)(3) of the Internal Revenue Code.

To facilitate thru arts and cultural activities, health HIV/AIDS and disease control awareness through workshops, seminars, fairs, outreach, and other programs targeted to minority and low income populations.

To develop a skills training center and or charter school to implement training in media radio and television, and produce a public access television program.

To establish and maintain a multicultural arts education, economic development corporation. With a emphasis on job creation, computer literacy, skills training, business development, skills training, wealth creation for low to moderate income individuals, welfare to workforce parents, at risk youth, the general public, the needy, the residents of Alachua and surrounding counties .

To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including without limitation the generality of the foregoing, to acquire by donation, contribution, bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its lease or otherwise any property of any sort or nature without limitation as to its amount or value, and hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income, principal and proceeds of such property, for any of the purposes set forth herein.

To do such things as are incidental to the purposes of the corporation or desirable to accomplish them.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. If reference to federal law in articles of incorporation imposes a limitation that is invalid in your state, you may wish to substitute the following for the last sentence of the preceding paragraph: "Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."
