In compliance with the requirements of Florida Statutes Chapter 617, the undersigned, being natural persons, hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a not-for-profit corporation.

ARTICLE I - NAME

The name of the corporation is City Players, Inc. ("Corporation").

ARTICLE II - DATE

The existence of the Corporation shall begin on the 17th day of March 2005.

ARTICLE III - ADDRESS

The street address of the principal office of the Corporation is 201 Leeward Island, Clearwater, FL 33767 and the mailing address shall be the same.

ARTICLE IV - PURPOSE

Said Corporation is organized exclusively for charitable, religious, educational, literary, and scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision(s) of any future United States internal revenue law.

Notwithstanding any other provision of these Articles, the Corporation will not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision(s) of any future United States internal revenue law.

ARTICLE V - DISSOLUTION

In the event of dissolution, the residual assets of the Corporation will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding provision(s) of any future United States internal revenue law or to the Federal, State or local government for exclusive public purpose.

ARTICLE VI - DIRECTORS

The manner in which the board of directors shall be elected or appointed are as stated in the Corporation's by-laws.
