

(A Florida Not For Profit Corporation)

Article I NAME

The name of this corporation shall be Squad 343, Inc., hereinafter called (the "Corporation").

Article II PRINCIPAL OFFICE AND/OR MAILING ADDRESS

The street address of the principal office of the Corporation is 141 S.E. 3rd Avenue, Suite 507, Dania, Florida 33004.

Article III PURPOSE

The Corporation is a not for profit corporation formed under the Florida Not For Profit Corporation Act (the "Act").

The Corporation is organized, and shall be operated exclusively, for educational and charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), and not for pecuniary profit. More specifically, the Corporation is organized and shall be operated exclusively:

To provide meaningful and continuing tribute and a permanent memorial to the memory of those brave firefighters and police officers who lost their lives in the 9/11 tragedy and further, through fundraising efforts, to provide resources and support for children in distress and related efforts.

MEMBERSHIP

The Corporation shall not have members.

Article V INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 141 S.E. 3rd Avenue, Suite 507, Dania, Florida 33004 and the name of the Corporation's initial registered agent at that address is William Monahan, 141 S.E. 3rd Avenue, Suite 507, Dania, Florida 33004.

Article VI BOARD OF DIRECTORS

The affairs of this Corporation shall be managed by a Board of Directors. The number of directors shall initially be three. The number of directors may be increased or decreased from time to time in accordance with the Bylaws of the Corporation, but shall never be less than three. The manner of election of members of the Board of Directors shall be regulated by the Bylaws of the Corporation. <u>Article VIII</u> DISSOLUTION

Upon the dissolution of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a not for profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its status as an organization described in section 501(c)(3) of the Code or corresponding provisions of any subsequent United States tax law, as selected by the Board of Directors.

Article IX LIMITATIONS

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation (except as otherwise provided in subsection (h) of section 501 of the Code), and the Corporation shall not participate or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation described in section 501(c)(3) of the Code (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Code (or the corresponding provision of any future United States tax law).
