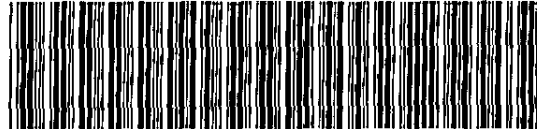

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I NAME

The Name of the corporation shall be: **Coalition 4 Responsible Growth, Inc.** effective April 1, 2005.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- a. To encourage and support responsible growth by effectuating positive change in laws, policies and procedures through partnerships within the community, with elected officials and governmental agencies; through public awareness initiatives; and through advocacy.
- b. To exercise all rights and powers conferred by the laws of the State of Florida upon not for profit corporations. It is not organized for the private gain of any person.
- c. The not for profit corporation shall not engage in any action which is not permitted to be carried on by not for profit corporations under the Internal Revenue Code, and no part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors or officers; but the corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of said purposes.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The initial board of directors will be appointed by the Incorporator with staggered terms up to three years. All directors thereafter shall have three year terms and be elected by two-thirds of the board of directors.
