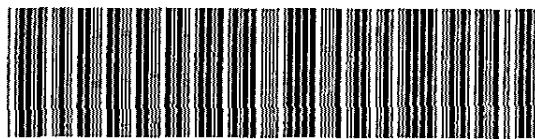

**ARTICLES OF INCORPORATION**  
**FAITH TEAM MINISTRIES INTERNATIONAL INC.**

The undersigned incorporators of Faith Team Ministries International Inc. hereby associate themselves together as a corporation not for profit and as a Christian religious society, under the following Articles of Incorporation, to wit:

**ARTICLE I NAME**

The name of the corporation shall be: Faith Team Ministries International Inc.

**ARTICLE II PRINCIPAL OFFICE**

**ARTICLE III PURPOSE OF CORPORATION**

**ARTICLE VIII 501(C)(3) ORGANIZATIONAL TEST AMENDMENT**

1. Faith Team Ministries International Inc. is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding section of any future Federal tax code).
2. No part of the net earnings of Faith Team Ministries International Inc. shall inure to the benefit of, or be distributable to, its members, trustees, directors, officers, or other private persons, except that Faith Team Ministries International Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution to furtherance of section 501(c)(3).
3. No substantial part of the activities of Faith Team Ministries International Inc. shall be the carrying on of propaganda or otherwise attempting to influence legislation, and Faith Team Ministries Inc. shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.
4. Notwithstanding any other provision of these articles, Faith Team Ministries International Inc. shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding section of any future Federal tax code).
5. Upon dissolution of Faith Team Ministries International Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or shall be distributed to the Federal, State or Local Government for a public purpose.
