COMES NOW the undersigned as the Secretary of Cathedral of Blessing Church, Inc., a Florida not for profit corporation executes this instrument for the purpose of filing the same with the Secretary of State of the State of Florida to indicate the following amendment to its Articles of Incorporation changing the listed Articles as follows:

Article I - Name

The name of the corporation shall be Cathedral of Blessing Christian Church (Disciples of Christ), Inc., a Florida not for profit corporation.

Article III - Purpose of the Corporation

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The specific purpose(s) for which the corporation is organized are: To promote, perpetuate and unite the Christian Faith according to the Holy Scriptures now taught and exemplified.

The corporation shall maintain and conduct its services as a member of the denomination of the Christian Church (Disciples of Christ) and shall fully participate with said denomination.

Article XIV - Dissolution

In the event of dissolution of this corporation, all of its assets remaining after payment of all costs and expenses of dissolution, shall be distributed to the Christian Church (Disciples of Christ) in Florida, Inc. as the Regional manifestation of the Christian Church (Disciples of Christ) Denomination. 


3. The Amendment was approved by a majority of the members of the corporation and all of the Directors of the corporation to be effective the 16th day of May 2008.



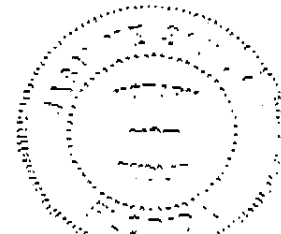
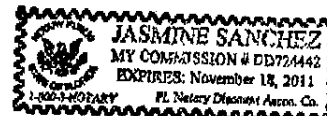
