AMENDMENT 2

Article IV: Purpose has been amended on July 1, 2006 by a vote of 5 yes, 0 no, 1 absent of the BOD to the following:

The St. Augustine Diocese House of Prayer and Evangelization Center is organized exclusively for charitable, religious and educational purposes as described in this Article, including the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code.

AMENDMENT 3

Article VI: Prohibited Activities Item #5 has been amended on July 1, 2006 by a vote of 5 yes, 0 no, 1 absent of the BOD to the following:

5. Income of the corporation shall not be paid to or distributed among the members, trustees, officers of the corporation or any private persons, except the corporation can authorize and empower to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of purposes of the organization as stated in Article IV.

AMENDMENT 4

Article VI: Prohibited Activities Item #7 has been amended on July 1, 2006 by a vote of 5 yes, 0 no, 1 absent of the BOD to the following:

7. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including publishing or distribution of statement) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions on this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

AMENDMENT 5

Article VII: Dissolution has been amended on July 1, 2006 by a vote of 5 yes, 0 no, 1 absent of the BOD to the following:

With dissolution or termination of the corporation, at any time, in any manner, and for any reason, the assets of the corporation that remain after payment of all liabilities of the corporation will be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to state or local governments, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of St Johns County or the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
