**ARTICLES OF INCORPORATION  
OF  
Project: Kids Cure Inc.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I NAME**

The name of the corporation shall be: **Project: Kids Cure Inc.**

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**ARTICLE III PURPOSES**

The specific purpose for which the corporation is organized is: Project: Kids Cure is established on the sole principle of finding a cure for malignant diseases affecting our children. Each year over 12,400 children are stricken with various debilitating childhood cancers. Approximately half of those affected are diagnosed with a rare, less common cancer, such as Neuroblastoma, Ewing's Sarcoma, and Wilms Tumor. Great strides have been taken in the research of these cancers but more is needed. Cancers such as Acute Lymphoblastic Leukemia (ALL), affecting the major population of childhood cancers, have seen such promising medical discoveries that survival rate are reaching upwards of 80% while the rarer, less common cancers receive little public or medical recognition. Great strides are needed to give these children a chance. The diversity of disease affecting less common cancers makes them unpopular for federal assistance and unknown to the general public. Determined doctors and scientists are enthusiastic and optimistic about fighting these diseases however the funds to perform grand scale cutting edge research are simply not there. As each day passes another generation's great minds are lured to more lucrative research programs affecting the masses while our children continue the ultimate fight. Determined to make an impact on the lives of children afflicted with rare malignant cancers (examples; Neuroblastoma, Ewing's Sarcoma and Wilms Tumor) we aim to fund the best in cutting edge treatment/research programs. Eighty percent of every dollar received will go directly to medical research grants and education programs. The Project will generate funds through individual contributions, special events, corporate sponsorships, and grants.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

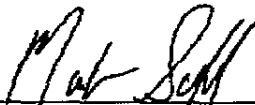
