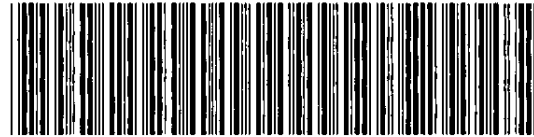


PURPOSES & DISSOLUTION OF THE NON PROFIT CORPORATION


