ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the Corporation shall be The Fisherman's Ministry, Inc. (the "Corporation").

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be 314 Mill Creek Court SE, Lake City, Florida 32025, or as such location as may be established by the Corporation's Board of Directors from time to time.

ARTICLE III PURPOSE

The purposes for which this Corporation is organized are exclusively religious and charitable purposes as defined under Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended, (the "Code"), or corresponding section of any future Federal tax code, not for pecuniary profit, including the performance of the following activities exclusively for such purposes.

- A. Preaching and teaching the Gospel of Jesus Christ and conducting all Ministry requirements as they may evolve, perpetuating the doctrine of the Bible, preaching, publishing and defending the Gospel, and undertaking such activities as will further the general purposes described herein.
- B. To conduct any and all lawful activities which may be necessary or useful in accomplishing the foregoing purposes; and
- C. The exercise of all powers conferred on a corporation organized under the Florida Not-For-Profit Corporation Act and Section 501 (c)(3) of the Internal Revenue Code.

ARTICLE IV MANNER OF ELECTION

The directors shall be elected in the manner provided in the Bylaws of the Corporation.

ARTICLE V INITIAL DIRECTORS AND/OR OFFICERS

The number of directors shall be specified, from time to time, by the Bylaws; provided, however, that the number of directors shall never be less than three (3), nor more than nine (9) with a minimum age of eighteen (18) years. A director may also be an officer of the Corporation.
