The undersigned, all of which are citizens of the United States, desiring to form a Non-

Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

The name of the Corporation shall be More Than Conquerors Faith and FIRST: Outreach Center, Inc.

The principal office of the Corporation is to be located at 4600 NW 143rd SECOND: Street, Gainesville, Florida, 32606.






