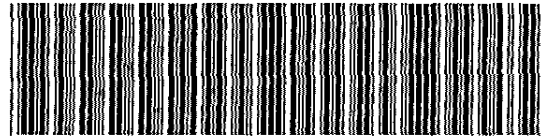

**ARTICLES OF INCORPORATION
OF
MORE THAN CONQUERORS FAITH AND OUTREACH CENTER, INC.**

The undersigned, all of which are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

FIRST: The name of the Corporation shall be **More Than Conquerors Faith and Outreach Center, Inc.**

SECOND: The principal office of the Corporation is to be located at 4600 NW 143rd Street, Gainesville, Florida, 32606.

The mailing address of the Corporation is 17027 NW 46th Avenue,
Alachua, Florida, 32615.

THIRD: a) Said Corporation is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any further tax code.

b) Said Corporation shall have full power and authority to purchase, lease, sell, and otherwise acquire, hold mortgage, convey, and otherwise dispose of all kinds and classes of property which this body may deem necessary and proper or expedient for the purpose

and successful prosecution of any and all of the objects for which this Corporation is formed and undertakes.

- c) Said Corporation shall have the right and power to license, ordain, and consecrate people desiring to become ministers of this faith and to exercise such authority over its membership through suitable and reasonable regulations and by-laws as may be appropriate for the establishment and maintenance of this body of Christian faith.
- d) Said Corporation shall have such additional right and purposes as are authorized by the laws of this State upon the adoption of a resolution authorizing the same to be done by the Corporation's Board of Trustees not inconsistent with the charitable non-profit corporations status herein being created.

FOURTH: a) The names and addresses of the persons who are the initial trustees of the Corporation are as follows:

The business affairs of this Corporation are to be managed or directed by the Board of Trustees, which shall be a minimum of three (3) members. These members shall serve until their successors are appointed. By-Laws governing the admissions of members, the rules, and

regulations to be observed, the qualifications for voting, resignation, the election powers, and duties of officers and general governing body, and all other matters and things usually and legally contained in corporate by-laws may, from time to time, be adopted, amended, or repealed by the affirmative vote of a majority of all members in good standing who are entitled to vote under the by-laws then existing. At all meetings of the membership, each member entitled to vote under the by-laws then in force may cast one vote.


b) The name and address of the initial registered agent of this Corporation is Aaron B. Rollins, 17027 NW 46th Avenue, Alachua, Florida 32615.


FIFTH: No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


SIXTH: Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code,


or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.




