ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be:

The Daytona Beach USBC Bowling Association, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE II PURPOSE

The purpose for which the corporation is organized is:

The encouragement, improvement and promotion of the game of bowling; to institute, conduct and manage tournaments of bowling of whatever nature and to fix the qualifications of the participants therein; to protect and promote the mutual interest of its members, who shall consist only of regularly organized bowling clubs, leagues, tournaments or teams of specific business houses, lodges, councils of a fraternal order military or governmental bodies, or social or athletic clubs and to do everything necessary and proper to the conduct of said purpose.

In furtherance of the foregoing objects, this association shall be conducted as a nonprofit organization, organized and operated at all times exclusively for charitable and educational purposes and, particularly, to foster local, regional, national and international bowling competition either directly or by contributions to organizations that are recognized as exempt from federal income taxation as organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. In furtherance of the foregoing purposes, this association shall be organized and operated primarily to conduct or support bowling competition and to support or develop amateur bowling athletes for national or international competition within the meaning of Section 501(j)(2) of the Internal Revenue Code of 1986, as amended.

Any such assets not so disposed of shall be disposed of by the Circuit Court in which the principal office of the Corporation is then located, exclusively for the purposes described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or to such organization or organizations as said Court shall determine are organized and operated exclusively for such purposes.
