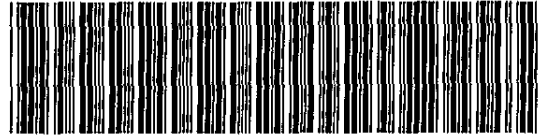

ARTICLE I

The name of the corporation is Youth Outreach Ministry of Monticello, Inc.

ARTICLE II

ARTICLE III

The duration of this Corporation shall be perpetual, and its purpose is:

To empower youth to build human character, educate and improve our communities which are very economically depressed in all areas. Further, we benefit minors to develop good character, good sportsmanship, by educating and culturally developing minors.

To assist youth and groups in developing; citizenship skills, knowledge of socioeconomic and educational systems, spiritually, culture, and skills necessary for any successful youth to strive and reside lawfully in the bounds of the law. Only those lawful activities which may be necessary, useful, or desirable for accomplishment and build self-esteem are embraced.

To raise the economic, educational and social levels of youth to include members of the minority community, who are deemed to be substantially unemployed, underemployed, or whose parents income is below federal poverty guidelines.

To foster and promote community wide interest and concerns for the problems of youth with regards to educational and economic opportunities to be expanded, i.e., sickness, poverty, crime, and that environmental degradation may be lessened also, that racial tensions, prejudice, discrimination, economic and otherwise may be eliminated.

ARTICLE VIII


To the fullest extent that the Florida Nonprofit Corporation Code, as it exists on the date here of or it may hereafter be amended, permits the limitation or elimination of the liability of Officers, no Director of the Corporation shall be personally liable to the Corporation or its members for monetary damages for breach of duty of care or other duty as a Director. No amendment to or repeal of the Article shall apply to or have any effect on the liability or alleged liability of any Director of the Corporation for or with respect to any acts or omissions of such Officer occurring prior to such amendment or repeal.

ARTICLE IX

Upon dissolution of the Corporation's affairs, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the Corporation, distribute, transfer, convey, deliver and pay over all of the assets of the Corporation then remaining in the hands of the Corporation to any other organization qualifying under Section 501 (c) (3) of the Internal Revenue Code as an exempt organization, to be used exclusively for charitable, educational or religious purposes or to the Federal Government, or to a State or Local Government for a public purpose.



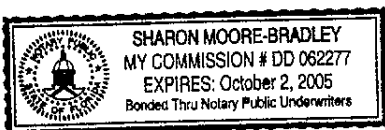
