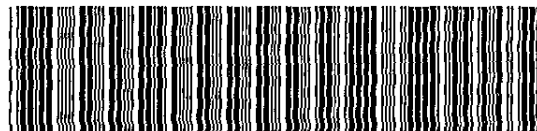



In compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE ONE.

NAME

The name of this corporation is **The Amos Center of Florida, Inc.**


