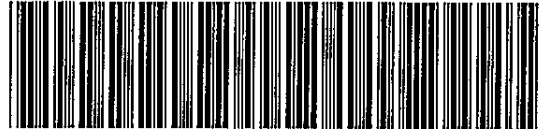

Article I NAME

The name of the corporation shall be:

All 4 One Motorcycle Club of Jacksonville (FL) Incorporated.

Article II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

Article III ORGANIZATION DESCRIPTION

All 4 One Motorcycle Club of Jacksonville (FL) Incorporated is comprised of a group of men and women of various backgrounds, histories, and lifestyles who have the common interest in owning and operating motorcycles to form a cohesive unit to promote unity. Members of this organization have made a personal commitment to support community health education in the areas of breast cancer, HIV/AIDS, and sickle cell.

Article IIII MISSION and PURPOSE

All 4 One Motorcycle Club of Jacksonville (FL) Inc. will strive support and enjoy the community and its charitable events while promoting a positive image for motorcyclists and motorcyclists enthusiasts.

Article V MANNER OF ELECTION

The President, Vice President, Secretary and Treasurer will be elected by majority vote during the organization's first meeting. The fore mentioned offices would be filled by a like election on an annual basis, which will be determined by the organization's by-laws. The initial Board of Directors or Executive Board shall be appointed to the organization's co-founders.

The Executive Officers of All 4 One Motorcycle Club of Jacksonville (FL) Inc. are as follows:

President - who shall hold office for one year and be granted the opportunity for re-election by the majority vote of its members in good standing.

Members in "good standing" will be defined by the organization's by-laws. There will be no term limits for the office of the President.

Vice President - who shall hold office for one year and be granted the opportunity for re-election by the majority vote of its members in good standing. Members in "good standing" will be defined by the organization's by-laws. There will be no term limits for the office of the Vice President. At any given point in time when the President is not present or active, the Vice President will govern the affairs of the organization as "acting" President until a President has been appointed by the Executive Board or by general election of the membership body. Solely the President may also appoint a member to the office of the Vice President in the event that the current Vice President is unable to fulfill his/her role and responsibilities as an officer. Members and other authoritative figures must refer to the by-laws of the organization for elaboration.

Secretary and Treasurer - who shall hold office for one year and be granted the opportunity for re-election by the majority vote of its members in good standing. Members in "good standing" will be defined by the organization's by-laws. There will be no term limits for the office of the Secretary or Treasurer. In the event that either office held is not in compliance or fulfilling its role and responsibilities, the President may appoint another member to assume the office for the remaining of the term.

General membership - is open to men and women who own and/or operate motorcycles of any make or model. Membership will encompass no maximum number of members.

Article VI

MANNER OF MEMBERSHIP TERMINATION

Termination of membership status may be acquired via three (3) alternatives. Officers and members of this corporation may terminate their membership voluntarily, be requested by organization's President to resign, or be expelled from the organization by the organization's Board of Directors which will consist of the President and Co-Founders based on the articles outlined in the organizations by-laws and code of conduct handbook.

Upon termination of membership of the organization, members are to participate in a formal hearing with the organization's Board of Directors and other officers if deemed necessary by the organization's President. Members to be terminated will be given the opportunity to have any questions asked or concerns addressed at that time. Remaining organization members and officers will be informed appropriately of the revised organization's membership roster.

Membership status may not be transferred to any other motorcycle club. Formal termination from All 4 One Motorcycle Club of Jacksonville (FL) Inc. must be achieved before any former member may be acknowledged as a member or another motorcycle club.

If for any reason an office bearer shall cease to act during his/her term in office, a successor shall be appointed by the president and shall hold office.

All terminations, whether voluntary or involuntary, will be made in writing and forwarded to the Board of Directors.

Article VII

DISTRIBUTION OF ASSETS

The distribution of assets upon dissolution, final liquidation, or if otherwise permitted by law, upon partial liquidation will be donated to another not for profit organization with a similar mission, to a charity of the organization's preference, or at the discretion of the executive officers. Such final decision will be made during a sanctioned meeting.
