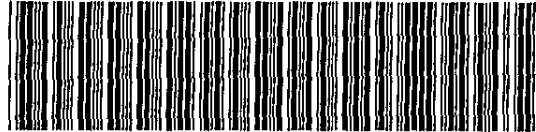

Articles of incorporation for a Not for Profit Corporation

We, the undersigned, hereby form, organize and incorporate under the laws of the State of Florida, by and under the provisions of the statues of the State of Florida providing for the formation, liability, rights, privileges and limitations of corporations not for profit, the above named corporation.

Article I: The name of this corporation shall be Kiwanis Club of Sawgrass Sunrise, Inc.

Article II: The purpose of the corporation is to engage in service activities, inclusive of charitable events and any other activity permitted under the laws of the United States and of the State of Florida.

Article III: This corporation is to have perpetual existence.

Article IV: This principal place of business of this corporation shall be 2355 NW 137th Terrace, Sunrise FL 33323 or in any other location in the State of Florida designated by the board of directors.

Article V: This corporation shall have 4 director(s). The number of directors may be increased or decrease from time to time in accordance with the terms and conditions of the by-laws adopted by the members, but shall never be less than three (3).

Article VI: The executive officer of this corporation shall be the president. The corporation may also have such officers and agents as may be deemed necessary and all such officers and agents shall be chosen in such manner, take and hold their officers for such terms, and have such powers and duties as may be prescribed by the by-laws, or determined by the board of directors.

Article VII: The corporation reserves the right to amend, alter, change, or repeal any provision contained in these articles of incorporation in the manner now or hereafter prescribed by law, and all rights and powers conferred therein upon stockholders, directors and officers and subject to this reserved power.

Article VIII: Every person who is now a director or who shall hereafter become a director of this corporation, shall be indemnified by the corporation against all costs and expenses (inclusive of legal fees) hereafter reasonably incurred by reason of their being a director of this corporation. The provisions of the statutes of the State of Florida in regards to indemnification shall govern the extent of this right to indemnification.
