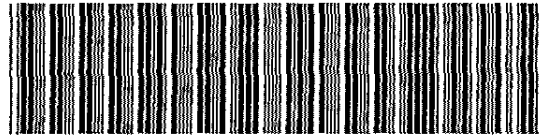

**NAME**

**ARTICLE III**  
**PURPOSE**

Academy of Performing Arts and Entertainment is a non-profit established under the laws of the state of Florida. The purpose for which the Academy is formed is one of social and human character offering acting classes, drama, music, dance, TV, film production and directing and others related to the entertainment world to persons desiring to be artists and professionals in those areas, to captivate those hidden talents with-in our community that could not ordinarily afford those classes, to assist those persons in achieving their dreams of becoming artists regardless of their age, race, disabilities, national origin or economic status given that all persons have a right to expose and develop their talents.

**SECTION 1**

"No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including, without limitation, the publishing, lobbying or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by: (a) a corporation exempt from Federal income tax under I.R.C. Section 501(c)(3), as amended; or (b) a corporation, contributions to which are deductible under I.R.C. Section 170(c)(2), as amended."

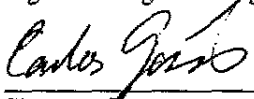

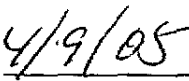
