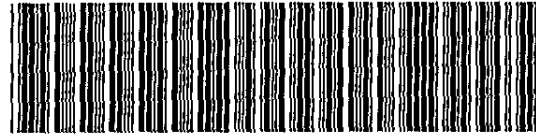

**ARTICLES OF INCORPORATION**  
In Compliance with Chapter 617, F.S. (Not for Profit)

**ARTICLE I NAME**

The Name of the corporation shall be: **Ruskin Incorporation Committee, Inc.** effective April 11, 2005.

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

Ruskin, Florida 33575-1111

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

- a. To distribute and communicate factual and balanced information to inform and educate the citizens of Ruskin, Florida to determine their support for placing the matter of Ruskin becoming a self-governing chartered municipality on a ballot, as provided by the Florida Constitution.
- b. To exercise all rights and powers conferred by the laws of the State of Florida upon not for profit corporations. It is not organized for the private gain of any person.
- c. The not for profit corporation shall not engage in any action which is not permitted to be carried on by not for profit corporations under the Internal Revenue Code, and no part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors or officers; but the corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of said purposes.

**ARTICLE IV MANNER OF ELECTION**

The manner in which the officers and directors are elected or appointed:

The initial officers will be selected and appointed by the Incorporator. The initial board of directors will be appointed by the Incorporator and approved by the Initial Officers. All officers and directors thereafter shall be elected or re-elected by two-thirds of the board of directors.
