Annual Report for 2007- 2008

With the assistance of North-South Institute and the USDA, the Southwest Broward Vegetable Association remains very active and has increased its membership with six (6) additional members. It has successfully planted, harvested and marketed the following produce of Pumpkins, Scotch Bonnet Peppers, Callaloo, Sorrel, Pak Chow, Okra, Eggplant, Cabbage, Tomatoes, and Spinach which has proven to be a good year in the farm business. We have held and conducted several scheduled Association meetings through out the year. We have been awarded and were the proud recipients of the Leadership Award in recognition of the outstanding service that we have given to the Community South Florida.

Farm Business Improvements

Members of the cooperative have recovered from the last hurricane of 2005 with the assistance of the USDA/FSA office and the technical assistance that has been offered through the North-South Institute. The cooperative have been able to become more organized by applying for our NAP Insurance coverage, completed farm diagnostic assessments of our farm business, completed our Census responsibilities and conducted a farm clean-up day and we are in the process of installing new portable sanitation.

Agricultural Business Training

The North-South Institute conducted the following training with our membership. The members of SBVGA strive to improve our farm operations and management through the support system and technology that has been offered to the members of the cooperative. The membership has attended several Farms related workshops and trainings that covered the following:

- Business Templates and Tools for Efficient Farm and Financial Record Keeping
- Enterprise Budgeting and Cost of Production
- Cash Flow Planning & Management
