ARTICLES OF AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF NEWCASTLE COURT CONDOMINIUM ASSOCIATION, INC.

The undersigned, certifies that:

- 1. She is the President of Newcastle Court Condominium Association, Inc., a Florida corporation, whose Articles of Incorporation were filed originally with the Secretary of State, State of Florida, on April 18, 2005, and Amended and Restated on September 23, 2005.
