# Articles of Incorporation

## Bayshore Professional Center Condominium Association Inc

(A NON-PROFIT FLORIDA CORPORATION)

### ARTICLE I.

The name of this corporation is BAYSHORE PROFESSIONAL CENTER CONDOMINIUM ASSOCIATION, INC. The initial principal office of the corporation is 109 Taylor Street - Suite 112, Punta Gorda, Florida 33950, and the initial mailing address of the corporation is 109 Taylor Street - Suite 112, Punta Gorda, Florida 33950.

#### ARTICLE II.

The purpose for which this corporation is organized is to act as the governing association of the proposed Bayshore Professional Center, a Condominium, located in Charlotte County, Florida, and to operate property owned by the Association.

#### ARTICLE III.
