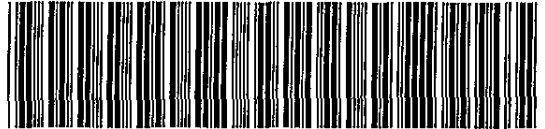

The undersigned, for the purpose of forming a corporation under the nonprofit laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the Corporation shall be Ensley Missionary Baptist Church, Inc.

ARTICLE II

The principle office of the corporation and the mailing address of the corporation is 241 East Ensley Street, Pensacola Florida 32514.

ARTICLE III

The purpose of this Corporation shall be to bring other individuals in to a personal relationship with Jesus Christ. 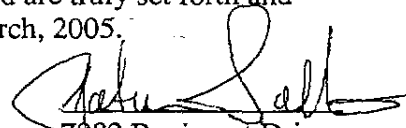
