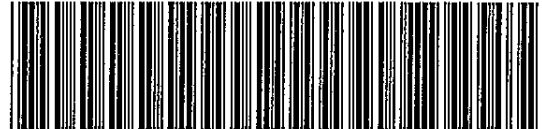

**ARTICLE I**  
Corporate Name

The name of this corporation is **CALVARY CHURCH INC. OF BEVERLY HILLS**

**ARTICLE II**  
Principal place of business and mailing address of the corporation.

**ARTICLE III**  
Purpose

The specific and primary purposes for which this corporation is formed are:

- a. The salvation of the lost
- b. To nourish and build up its members in the faith, thus encouraging growth in the grace and knowledge of our Lord and Savior Jesus Christ.
- c. To encourage and advance Christian fellowship among the members and other believers of like faith and practice, in conformity with the New Testament Standards.
- d. To operate exclusively in any other manner for such religious purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code, as amended, or under any corresponding provisions of any subsequent federal tax laws, covering the distributions to organizations qualified as tax exempt, organizations under the Internal Revenue Code, including private foundations and private operating foundations.

**ARTICLE IV**  
**Manner of Election**

a. Administrators. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of Administrators. The number of Administrators of the corporation shall be four. The Administrators shall be appointed by the Deacon Body.

The Administrators named herein as the first Board of Administrators shall hold office until March 2006. At this time the Deacon Body will appoint new Administrators for the following year and file the Annual Report with their name with the State of Florida. Administrators hereafter will hold office for a period of one year.

Any action required or permitted to be taken by the Board of Administrators under any provision of law may be taken without a meeting if approved of by the Deacon Body with written permission by each member of the Deacon Body. Such written consent or consents shall be filed with the minutes of the proceedings of the board, and any such action by written consent shall have the same force and effect as if taken by unanimous vote of the church membership.

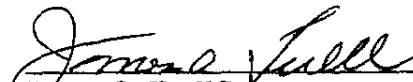
