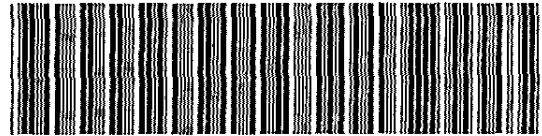

**ARTICLES OF INCORPORATION
OF**

DAUGHTERS OF THE MOST HIGH DISCIPLESHIP MINISTRY, INC.

ARTICLE I.

The name of the Corporation is "Daughters of the Most High Discipleship Ministry, Inc."

ARTICLE II.

The Corporation is organized pursuant to the Florida Non-Profit Corporation Code.

ARTICLE III.

The Corporation shall have perpetual duration.

ARTICLE IV.

The Corporation will be organized exclusively for religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the 1986 International Revenue Code.

ARTICLE IV(a).

The purpose of this corporation is to assist Christian women in understanding, embracing and proclaiming their true identity to fulfill their destiny in what God has called Christian women to be as servants at home, church, work and community throughout the world.

ARTICLE V.

The method of election of the Corporation's directors shall be set forth in the Bylaws of the Corporation.

ARTICLE VI.

Notwithstanding any other provision of these articles the corporation will not carry on any other activities not permitted to be carried out by:

- (a) a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law; or
- (b) a corporation contributions to which are deductible under Section 178(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States Revenue Law.

ARTICLE VII.

Upon dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, ie., charitable, education, religious or corresponding section of any future tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.

ARTICLE VIII.

The initial registered office of the Corporation shall be **926 Olive Tree Circle, West Palm Beach, Florida 33413** and the initial registered agent of the Corporation at such address shall be **Michelle R. Clark**.
