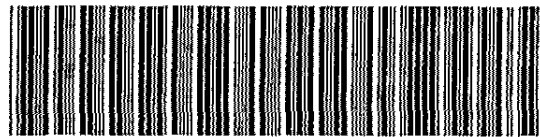

- Article I: The name of the corporation will be Community Challenges, Inc.
- Article II: The principal place of business will be:
875 Dr. Mary McLeod Bethune Boulevard, Daytona Beach, FL 32114.
- Article III: The specific purposes for which the corporation is organized:
- To collaborate with health and human service providers to enhance, empower and educate individuals in the community.
 - To improve outreach efforts and/or initiatives by developing partnerships with community stakeholders.
 - Reduce challenges (barriers) that reduce access to adequate health, housing, employment and social services.
