**ARTICLES OF INCORPORATION
OF
SOUTHWEST FLORIDA TRUCKERS ASSOCIATION, INC.
(A Not-For-Profit Corporation)**

The undersigned, acting as the incorporator of a Corporation pursuant to Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation of such Corporation.

FIRST: The name of the corporation (the "Corporation") is:

Southwest Florida Trucker's Association, Inc.

SECOND: The street address of the corporation's registered office, initial principal office, and the mailing address of the Corporation is:

THIRD: The purpose for which the Corporation is organized is to promote public awareness of the concerns of individuals involved in commercial trucking in Southwest Florida.

FOURTH: The method of the election of directors of the corporation shall be as stated in the Bylaws of the Corporation

There is no provision which limits the manner in which the Corporate powers are authorized under this act.

All actions taken by or on behalf of the Corporation shall be consistent with the laws of the State of Florida.

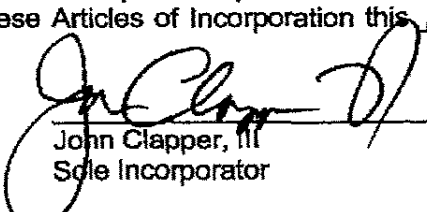

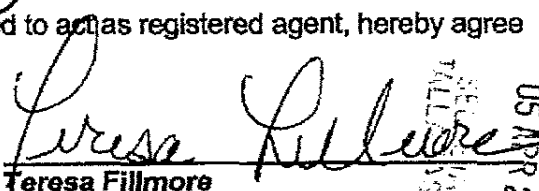

NINTH: The membership status of an individual may be terminated for non payment of dues, or by a majority vote of the Directors of the Corporation upon a determination by said Board that a member has acted inconsistently with corporate purposes.

IN WITNESS WHEREOF, the undersigned, being the sole incorporator herein before named, for the purpose of forming a not-for-profit corporation under the Florida Business Corporation Act, has executed these Articles of Incorporation this 19 day of April, 2005.
