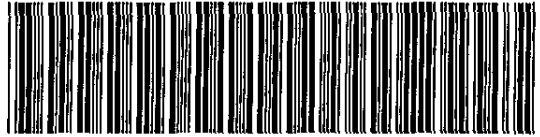



ARTICLES OF INCORPORATION

We the undersigned for the purpose of forming a non-profit Corporation, pursuant to Florida Chapter 617, present the following Articles of Incorporation.

ARTICLE I

NAME

The name of the non-profit corporation shall be Woodie's Dream Team Foundation, Inc.

ARTICLE II

ADDRESS

The principal place of business of the Corporation in Florida and the mailing address shall be 5715 36th Avenue East, Palmetto, Florida 34221.

ARTICLE III

PURPOSE OF THE CORPORATION

The primary purpose of this Corporation is to develop well rounded individuals by providing teenagers with a place they can go to received help in all areas of their development academically, socially, emotionally, character building and career planning.

Further, to provide scholarships for kids to go to camp, provide transportation to camps, provide test fees and other necessary fees for SAT, ACT, Clearing House, etc., provide tutors for academic improvement, provide mentors for social skills, career planning, character building, financial planning, and other needs the teenagers may have, provide beauty and/or barber shop to foster pride in appearance and to provide a "clothes loan closet" for professional and social needs for job interviews, college interviews, prom, etc.

The corporation shall have the power to acquire and hold title to real and personal property and in essence, to perform activities not in conflict with the laws of Florida.

ARTICLE IV

BOARD OF DIRECTORS

The initial board of directors shall consist of twelve (12) members. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than three (3). The method of election shall be stated in the bylaws. 




