# ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

#### ARTICLE I NAME

The name of the corporation shall be:
Independent North Miami Seventh Day Adventist Church, Inc.

#### AKTICLE II PRINCIPAL OFFICE

#### ARTICLE III PURPOSE

The purpose for which the corporation is organized is: Religious, Spiritual, Charitable and Educational Purposes.

## ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Officers are elected every one or two years through an appointed nominating committee. This committee brings its report to the church, which then acts on the names presented. This procedure enables the church to give careful study to each name prior to election, and avoids the public competitive element that may arise when nominations are made from the floor. The nominating committee shall study the needs of the church and make careful inquiry into the fitness of members to serve in the different offices. For this reason officers shall not be nominated from the floor or by general ballot. The nominating committee will range from no less than five members. This matter should be studied by the church board prior to presentation to the church. A suitable recommendation may then be brought to the church, using a minimum of time in the Sabbath worship hour.
