SECRETARY OF STATE TALLAHASSEE FLORIDA

(A NON-PROFIT FLORIDA CORPORATION)

ARTICLE I.

The name of this corporation is BEECHWOOD VILLAS CONDOMINIUM ASSOCIATION, INC. The initial principal office of the corporation is 1264 Market Circle, Unit 2, Port Charlotte, FL 33948, and the mailing address of the corporation is P.O. Box 2114, Englewood, FL 34295.

ARTICLE II.
